Our health programs



Provides free, confidential practical support to people facing barriers to accessing GP services. Open to anyone who lives in the UK.



Outreach

Supports people seeking asylum accommodated in Northeast London Hotels with Initial Health Assessments by a DOTW GP and GP registration

Supports people excluded from health with PHC and registration.



- NEL: 233 (Initial Health Assessments and/or support with GP registration)
- Stratford Clinic: 267 (GP registration advocacy, medical consults and/or health access advice/support for e.g.: HC1 support, signposting)
- Advice Line: 148 (GP registration advocacy, medical consults and/or health access advice/support for e.g.: HC1 support, signposting)
- Migrant Health: 257 (initial and repeat consultations)


Access to primary healthcare

Safe Surgeries included throughout
NHS England's new training course
on GP registration for people
experiencing homelessness

Supports people who have been denied (or asked to pay upfront for) NHS secondary care (hospital services) due to their immigration status.

Access to PHC - Safe Surgeries

- Started in 2019 ambition to advocate to PHC providers on rights of access for vulnerable people.
- 2,400 NHS staff completed e-Learning (900 of these were in November and December following re-launch) in 2024
- 29 training session, reaching over 1,000 primary care staff in 2024
- 360 new Safe Surgeries in 2024
- 2,250 total Safe Surgeries since 2019
 - 53 ICBs/ health bodies promoted Safe Surgeries
 - 1,411 Safe Surgeries toolkit downloads



Introduction

The Department of Health and Social Care (DHSC) has extended eligibility for the <u>Healthy Start scheme</u> to British children aged under 4 years old whose parent or guardian meets the financial eligibility criteria and is either:

- subject to a no recourse to public funds (NRPF) condition (as attached to their immigration permission)
- without any immigration status

To qualify for the extension, you must meet all of the following criteria



General

- <20 FTE
- Budget £1,2 million
- Small shared office space
- MT changeover


- Streamline domestic programs
- Limited funding in UK for the above
- Focus on Policy work
- Promote partnership working
- Prioritize outreach/mobile work
